Congressional Scorecard

How to Judge a Member's Voting Record

AFSCME selects a few roll-call votes from the hundreds cast by members of Congress every session. In choosing these votes, AFSCME attempts to fairly represent a lawmaker's position on issues determined to be important to AFSCME members — first and foremost as workers, but also as citizens and union brothers and sisters.

This voting scorecard is one of the key factors used in making judgments on AFSCME campaign support, endorsements or contributions from PEOPLE — AFSCME's Political Action Committee or PAC. Other important factors often include the member's official leadership position, chairmanship or seniority on important committees, leadership in a state's congressional delegation, and accessibility and responsiveness to AFSCME's lobbying efforts.

2010 House Vote Descriptions

1. Reforming Health Care

AFSCME Position: Yes

The House of Representatives passed the Health Care and Education Reconciliation Act of 2010 (H.R. 4872), legislation that made key improvements to the Patient Protection and Affordable Care Act, historic health care reform legislation that puts the country on a path toward addressing skyrocketing costs and insurance company abuses. Key improvements included changes to limit the impact of an excise tax on health plans provided by employers and increased funding for state Medicaid programs.



House Vote Number 167

AFSCME supported the bill, which the House approved by a vote of 220-211 on March 21, 2010.

2. Transforming Wall Street's Business Practices

AFSCME Position: Yes

The House of Representatives passed the Wall Street Reform and Consumer Protection Act of 2009 (H.R. 4173) to rein in Wall Street's reckless business practices that led to the

worst recession in a generation. It enacted new, strong consumer protections to shield consumers and shareholders from risky financial products.

House Vote Number 413

AFSCME supported the bill, which the House passed by a vote of 237-192 on June 30, 2010.

3. Extending Long-Term Unemployment Insurance

AFSCME Position: Yes

The House of Representatives passed the Restoration of Emergency Unemployment Compensation Act (H.R. 5618) to extend for two months federal unemployment benefits, flood insurance programs, increased payment rates to Medicare providers, and COBRA health care premium assistance.

House Vote Number 423

AFSCME supported the bill, which the House approved by a vote of 270-153 on July 1, 2010.

4. Creating Collective Bargaining Rights for Public Safety Officers

AFSCME Position: Yes

The House of Representatives passed the Emergency Supplemental and Disaster Relief and Summer Jobs Act of 2010 (H.R. 4899), which included the provisions of the Public Safety Officers Employer-Employee Cooperation Act establishing collective bargaining rights for public safety officers.

House Vote Number 430

AFSCME supported this bill, which the House passed by a vote of 239-182 on July 1, 2010.

5. Creating Jobs by Extending State Fiscal Relief and Education Funding

AFSCME Position: Yes

The House of Representatives approved new jobs legislation (H.R. 1586), which provides \$16.1 billion in Federal Medical Assistance Percentages (FMAP) funding for state Medicaid programs and \$10 billion to states for education funding to preserve jobs and avert massive layoffs.

House Vote Number 518

AFSCME supported this bill, which the House passed by a vote of 247-161 on August 10, 2010.



6. Providing Medical Services to 9/11 First Responders

AFSCME Position: Yes

The House of Representatives passed the James Zadroga 9/11 Health and Compensation Act of 2010 (H.R. 847), which created a program to provide medical services and health monitoring for first responders and others with conditions related to the September 11 attacks and reopened the Sept. 11 Victim Compensation Fund to provide compensation for economic losses for those affected by the attacks.

House Vote Number 550

AFSCME supported this bill, which the House passed by a vote of 268-160 on September 29, 2010. The bill cleared the Senate by a voice vote in December 2010.

7. Enhancing Funding for Child Nutrition Programs

AFSCME Position: Yes

The House passed the Healthy, Hunger-Free Kids Act of 2010 (S. 3307), which reauthorized child nutrition programs through FY 2015 and increased funding for these programs by \$4.5 billion over 10 years. The bill also set nutrition standards for food sold in schools and increased reimbursement rates for those schools under compliance with the new standards.

House Vote Number 603

AFSCME supported this bill, which the House approved by a vote of 264-157 on December 2, 2010.

8. Cutting Taxes for Middle Class Families

AFSCME Position: Yes

The House passed the Middle Class Tax Relief Act (H.R. 4853), which would make permanent the 2001 and 2003 tax cuts on income under \$200,000 for individuals and \$250,000 for households. The legislation also expanded the child tax credit.

House Vote Number 604

AFSCME supported this bill, which the House approved by a vote of 234-188 on December 2, 2010.
